

Refowitz to Lead Health Care Agency

After serving as the Agency's Interim Director since February, Mark A. Refowitz was appointed to the position of Health Care Agency (HCA) Director effective June 11 by County Executive Officer Thomas G. Mauk.

"I've been given a wonderful opportunity to lead the Health Care Agency and continue the focus on providing high quality services to our community in times of budgetary challenges," Refowitz stated. "We know that health matters to every individual, their family and the community as a whole. As Director of HCA, I hope to reach out and work with our community in new and different ways to promote the wellness of all Orange County residents."



Agency's Deputy Agency Director for Behavioral Health Services, where he was responsible for mental health services for adults, youth and children as well as alcohol and drug abuse services. During his tenure in that position, Refowitz directed the implementation of the local Mental Health Services Act program with an annual budget of approximately \$100 million. As Health Care Agency Director, he succeeds David L. Riley, who retired in January.

Prior to joining HCA, Refowitz served as Director of Mental Health Services for the County of San Diego Health and Human Services Agency. During his professional career, he has also served as Assistant Commissioner for Managed Care for the Massachusetts Department of Mental Health as well as in management positions with several other health organizations. Refowitz has a Master's Degree in Social Work from the University of Connecticut and is a former President of the California Mental Health Directors Association.

Fifteen County Programs Receive NACo Awards, Including One "Best of Category"

Fifteen County of Orange programs were selected to receive a 2012 Achievement Award by the National Association of Counties (NACo). Among these, the Registrar of Voters' **My Ballot** program to teach high school students the value of our electoral process, democracy, and civic participation was also designated "Best of Category" in the Civic Education and Public Information category. *(Continued on page 2)*

"We are honored to have been recognized by NACo and appreciate the opportunity to share innovative County programs that best demonstrate our efforts to provide efficient, quality services to the residents of Orange County," said Chairman John M.W. Moorlach, Board of Supervisors.

The fourteen additional Orange County programs to receive Achievement Awards are:

- 1.62 Defined Contribution Plan for New Employees: In an effort to address increasing pension costs, the County's Human Resources Department initiated steps towards implementing a new lower retirement formula, "1.62% at 65," combined with a Defined Contribution Plan.
- Amnesty Program for Patrons with Overdue Fines: From September 12 -18, 2011, patrons with overdue OC Public Libraries material could return the item(s) to the branch and have associated fines waived. During Amnesty Week, attendance increased by more than 4,500 library visitors over the same week in 2010.
- Archaeological and Paleontological Partnership Program: OC Community Resources' OC Parks division and California State University, Fullerton (CSUF) entered into a partnership agreement in December 2009 for CSUF to manage, curate, and display a world-class archaeological and paleontological collection.
- Blended Tutor Training Program: This OC Community Resources' OC Public Libraries division program includes a new type of adult literacy tutor training program, blending traditional face-to-face instruction with self-paced training through alternative technologies.

- Blogger Preview Heritage Hill Seasonal Event: OC Community Resources' OC Parks division utilized a no-cost marketing technique to increase attendance at two annual holiday events.
- Differential Response Path One: The Differential Response Path One program was designed by the Social Services Agency to identify, prevent and treat child abuse in order to prevent families/children from coming into the child welfare system and/ or to prevent or minimize recurrence of child abuse within certain families.
- eReader Open House Program: OC Community Resources' OC Public Libraries division created the eReader Open House Program in response to the growing demand for eAudio and eBook materials. The program provides hands-on training for both staff and community that allow them to utilize and enjoy new library resources with their reading devices.
- Health Care Agency Leadership Development Program: This three-level leadership training program provides Health Care Agency employees with ongoing development that contributes to personal and professional growth.
- Historical Sheet Music Digital Collection Project: To improve access to a popular sheet music collection, the OC Community

Resources' OC Public Libraries division created the Historical Sheet Music Digital Collection Project, which digitized over 400 pieces of full-color sheet music owned by the Cypress Branch Library.


- OC Parks Ranger Training Academy: The OC Parks Ranger Academy is the only academy in the United States specific to the role of county and regional park rangers. Rather than sending recruits through a law-enforcement academy that provides only some of the needed skills, the OC Parks Ranger Academy trains current and prospective park rangers with the specialized skills necessary to be an exceptional park ranger.
- Poll Worker Training Video: The Orange County Registrar of Voters Poll Worker Training Video was developed to improve the quality of training for the thousands of volunteers who serve as poll workers on Election Day.
- **ProgPay Computer Application System:** The ProgPay system was developed for the Inspection Section of the OC Public

Works Department, which plans and implements County funded capital improvement projects. When plans are approved, requests for bids are advertised via the internet. The ProgPay system then tracks the progress made by the contractor on the projects down to each line item of work.

- Setting Appropriate Orders: A Child Support Best Practice Program: This Child Support Services program has provided hard empirical data to guide child support professionals such as caseworkers, attorneys, and court commissioners nationwide in creating appropriate orders at the establishment of a case to yield the greatest likelihood of future payments.
- Supervisor Enhancement Leadership Forum: The Child Support Services Supervisor Enhancement Leadership Forum was developed to provide supervisors, managers and other leaders who supervise staff with an opportunity to participate in leadership development.

2012 Presidential Primary Election Recap

On June 5th, the Orange County Registrar of Voters (ROV) executed yet another successful Election Day with the help of 160 full-time and part-time staff members and over 5,000 volunteers.

The department received and processed 426,869 ballots, representing a 26.5% turnout in comparison to the County's 1.6 million registered voters. Voters in the County largely preferred voting by mail, with only 9% of the individuals who voted doing so at designated polling places.

The culmination of almost a year of preparation, recruitment, registration and voter education efforts, the 2012 California Primary was significantly different than elections past. Featuring new ballots and new districts, the Primary Election garnered national attention as the country watched for the effects of recently enacted redistricting. Following Proposition 14 in 2010, the state adopted a "Top Two Primary" system that allowed voters to select candidates for state and federal offices regardless of party affiliation, making it possible for the General Election contests to include two candidates of the same party. In addition, the recent redistricting resulted in new district lines for hundreds of thousands of County residents.

In response to the changes to the state's elections processes, the ROV rolled out a number of programs oriented toward voter and volun-

teer education. Materials given to the department's 5,000 volunteers were adjusted and extensive training was provided on new ballot options for voters at the polls. A Proposition 14 Speakers Bureau was developed in 2011 to reach different community organizations and ROV Neal Kelley or the department's Street Team were present at meetings and community events to remind voters that the recent Primary had important differences from previous elections.

Despite the new Primary process and districts, poll workers, voters and ROV staff report that the election went smoothly. Countywide, voters passed Measure B, the Mandatory Minimum Pension Selection, a measure requiring

new members of the Board of Supervisors to enroll in the 1.62% at 65 pension option by a wide margin- with 72.4% voting in favor and only 27.6% voting against. Measure A, the initiative to change the Public Administrator's office to an appointed position from an elected one, did not fare as well and was defeated 60.5% to 39.5%. Both measures required a simple majority vote to pass.

In other County contests, former Supervisor Todd Spitzer was elected to fill the upcoming vacancy in the 3rd Supervisorial District, receiving 68.9% of the vote. Elected in 1997 to the Board of Supervisors to a seat made vacant by a resignation, Spitzer served until being elected to the California State Assembly in 2002. He will return to the Board in 2013.

Incumbent Supervisor Janet Nguyen garnered 74.2% of the vote, winning re-election to the 2nd District. This Primary marked Nguyen's 2nd re-election to the Board of Supervisors, after being elected via special election in 2007 and re-elected to her first full term in 2008.

Orange County was the first of the large counties to certify its results, concluding the ballot processing on June 15th. On Election Night, Orange County was also the only jurisdiction statewide to have received and sorted the supplies used by poll workers and voters on Election Day thanks to the sophisticated use of automated conveyor belts and almost one hundred volunteers. "This change in our sorting system has allowed us to reduce costs and shorten the time needed to certify," said Neal Kelley, Registrar of Voters. "We are looking forward to our biggest election in four years, which will be the Presidential Election on November 6th."

OC Public Works Partners with OC Waste & Recycling to Host Fourth District Community Clean-Up Day

More than 25 volunteers from OC Public Works (OCPW) and OC Waste & Recycling (OCWR) hosted Community Clean-Up Day in the unincorporated West Anaheim islands on Saturday, June 2nd – continuing to build momentum in an effort that has included similar successful events in unincorporated El Modena, Stanton, and the Midway City islands.

Over the weekends leading up to the event, OCPW Director of Planning Rick LeFeuvre and his family spent many hours walking door-to-door throughout the area, distributing over 1,500 door hanger flyers to spread the word about the upcoming event to residents.

On the big day, OCWR Recycling and Environmental Programs Manager Isabel Rios arranged for the delivery of 12, 40-

yard roll-off containers to strategic locations, giving community members the opportunity to dispose of household waste and debris like old furniture, mattresses and yard refuse at no cost. Two to three staff members were stationed at each site, ready to assist participants with unloading. "The event was so well embraced by the residents that one of the roll-off containers was full before 8 a.m." said Rios.

A local church lent a hand by allowing the County to stage an E-waste drop-off collection site in its parking lot, where residents disposed of their old televisions and other electronic items. "Overall, an estimated 36-40 tons of refuse was removed from the community and, before the event was over, our volunteers were already being asked to return in the future," said OCPW Neighborhood Preservation Unit Manager Eric Hull.

As Community Clean-Up Day concluded, 4th District Supervisor Shawn Nelson treated all of the volunteers to a barbeque of hot dogs and polish sausages prepared by Policy Advisor Steve Spernak. "It was great to see the neighborhood work as a team and take pride in their surroundings," said Supervisor Nelson. "We enjoyed meeting new neighbors and saying hello to some old friends. With help from OC Public Works and OC Waste & Recycling, I was proud to be a part of the community taking ownership of continually improving North Orange County."
