



## Ask the CEO



**We're off!!** The new fiscal year has begun based on the Board of Supervisors' action on June 27 that approved a \$5.6 billion budget. The Board conducted a thorough review of the proposed budget on June 13 and 14, and proposed revisions, including an additional \$10 million for Medical Services for Indigents, for consideration in the final budget adoption. The adopted budget includes several important Board-approved augmentations including:

1. \$700,000 to expand the District Attorney's High Tech Crime Unit
2. \$500,000 to expand the number of bed nights at the cold weather shelter armory
3. \$1.1 million to increase service levels in SSA's Children & Family services
4. \$1 million for an additional field services unit to increase supervision of probationers
5. \$10 million toward the replacement of the CAPS System

## Employee Survey Successfully Launched

In less than two weeks since the launch of the first-ever, County-wide employee survey, more than 3,000 responses have been received with about three weeks remaining until the deadline. All employees should have now received or have access to the confidential survey that is an essential part of the Strategic Focus effort.


Employees who do not have direct access to a computer should have already received a hard copy of the memo from Chairman Bill Campbell and CEO Thomas G. Mauk with the employee's Username and PIN which enable them to access the survey. The Username and PIN can only be used once to complete the survey and, thereby, ensure the confidentiality and credibility of the survey. Employees without their own computers should check with

their Department Heads for direction to a computer terminal on which to take the survey.

"We need the participation and feedback of all County employees to help us shape the course for the future," said Chairman Bill Campbell. "To ensure that employees are comfortable with candid replies, this survey is being analyzed and summarized by MGH Consulting, an outside, independent firm."

The survey will take no more than 15 – 20 minutes to complete. It is available online to employees until August 31. After all the survey input is received, a summary report will be completed by early October, and will be shared with employees.

Budget approval also allows the staff to move forward with several other program-related Board priorities including:

- Graffiti abatement on private property
- The addition of a third Youth & Family Resource Center
- Funding for the CEO, Social Services Agency and Housing & Community Services to coordinate the development of disaster planning for the County
- Increased funding for preventive maintenance of County facilities

On the Retiree Medical front, the working group established by the Board is about half-way through the process of developing recommendations. Additionally, the Chairman has, with Board support, instructed the Human Resources/Employee Relations Department to meet regularly with Retired Employees Association of Orange County (REAOC) to receive input directly from retirees.

On a more personal front, I appreciate all your efforts in conserving electricity demand during the heat wave. It's another way that we can all pitch in to accomplish an overall goal. Thank you as well for the good response we've seen to the employee survey. You will receive weekly updates on our progress in that area.

## County Booths Bring Home Ribbons from the OC Fair

The Year of the Garden was in full bloom at the 2006 Orange County Fair where more than 900,000 guests took part in mouth-watering culinary delights, thrilling carnival rides and family attractions. Visitors also enjoyed the twin treats of information and entertainment created for displays by representatives from County departments and agencies.

Employees from Animal Care Services, Assessor, Clerk-Recorder, Homeless Prevention, Health Care Agency, Integrated Waste Management, John Wayne Airport, Law Library, Office on Aging, Probation, Public Library, Registrar of Voters, Sheriff-Coroner, Social Services and Superior Court welcomed Fair visitors from July 7 – 30.

Several booths were honored with Orange County Building awards in the Government Agency competition. The Orange County Sheriff's Department won first place for Best of Show, while Assessor's Office received second place for both theme and educational content. Probation completed the trio with a third place for educational material.

The Registrar of Voters Office drew inspiration from the Fair's Flower Power theme by inviting the crowd to pick their favorite flower using one of the newly introduced electronic voting machines. This creative display brought home first place in the variety/interactive category, where the incumbent California Poppy closely won the fragrant election by 16 votes over the Blue

perience."

The day will abound with events for adults and children including free activities for kids such as clowns, face painters, and bounce houses. There will also be golf putting; golf pitching, dunk tank, midway games and Irvine Park's existing amenities like train rides, pony rides and bicycles — all at discounted prices. There will also be live music, food and non-alcoholic beverages.

United Way Chairman Bryan Speegle said that friendly competition among departments will be encouraged as teams sign up for the tug-of-war, three-legged race, sack race and relay races. The team with the highest score at the end of the day will get to take home a trophy -- and bragging rights for the next 12 months. Teams are comprised of 8-10 employees. ## Get The 411 On OC Child Support Services

1. Child Support Services (CSS) collected and distributed a record \$178.3 million to secure the financial and medical well-being of Orange County families in 2005.
2. Technological advances play an integral part in the collection and distribution of funds. Currently, clients have the option to receive funds via direct deposit, and employers may transfer funds electronically. Non-custodial parents have the option of sending support via credit card or debit card in addition to more traditional means such as checks and money orders.
3. CSS staff includes trained family law attorneys and more than 300 caseworkers who help locate absent parents, establish paternity, set up court orders for the financial and medical support of minor children and enforce court orders. All services, funded through State and Federal monies, are provided free of charge to the client.
4. The County of Orange is one of the top six California counties in terms of total case loads. Despite that, the County's CSS leads the other five in the following areas:
  - Per case collection
  - Percentage of children with established paternity
  - Percentage of cases with an established court order
  - Percentage of current collected support
  - Percentage of cases with arrears collection
