

His mobile office is a white SUV that drives up and down the bike path along the banks of the Santa Ana River flood control channel. Here's the story of how Chuck DeWitt helps people most in need.

omeless encampments can be seen out every window. His left arm rests comfortably, jutting outside of the white SUV as it rolls leisurely down the bike trail along the Santa Ana River flood control channel. Every 10 feet or so, the people living in the encampments call out to him. They call out for a variety of reasons- some looking for resources, some asking for forms and some just to say hello.

"90 percent of the people down here know me," says Chuck DeWitt, Mental Health Specialist for the

Health Care Agency Outreach and Engagement team. "I'm not out here telling them what to do, I'm here to help with whatever they need."

As a Mental Health Specialist, Chuck's focus is on providing resources related to mental health. He goes where the resources are needed the most and spends at least two days each week driving along the bike path adjacent to the Santa Ana River flood control channel. In 12 years with HCA, Chuck has seen a dramatic change.

"It's not just about mental health. We provide

whatever resources we can," Chuck says, after he gives a DMV identification card form to a man he's given the same form to four times this month. "You have to be flexible, ready to readjust and just go with it."

Chuck is part of an 18-person Outreach and Engagement Team at HCA in the Behavioral Health Services division. Consisting of clinical social workers and mental health specialists, the program provides services to underserved or isolated people at risk of developing behavioral health conditions. They provide education, assessment, short-term case management, educational and life skills classes, support groups, transportation assistance and inperson outreach. Chuck proudly talks about how the team collaborates and draws on one another to connect people to resources.

"We're like a walking directory," he says.

He's able to help largely because he knows firsthand what it's like to be in their shoes. Chuck readily shares that he has a "colored background" as he was once homeless and struggled with addiction. Now 66 years old, and sober for 15 years, Chuck says it's his background that allows him to connect with the people he works with in a straightforward way.

"It takes a special breed to work out here," Chuck said, adding that people don't realize how tough their job is. He is constantly on the move walking from encampment to encampment, his punctureresistant boots stepping over trash, needles and personal belongings. Chuck and the rest of the team do everything they can to help people overcome barriers.

One man waves Chuck down, seemingly both to say hello and to ask for a form. As Chuck's partner Brigitte Juhasz, Clinical Social Worker, completes the requested form, Chuck asks the man if he remembers talking to him last week. The man sheepishly says he does and promises that he is taking the form straight to the DMV this time. "When I see your face, I just want to ask for help," the man tells Chuck.

The hardest part, Chuck admits, is twofold. The first is having to walk away when people won't accept resources that could help. The second is being yelled at by the general public while doing their outreach work. Chuck says that they regularly hear frustrations from people along the flood control channel in businesses, residences or using the bike trail. They either blame him for the encampments being there or are angry that they're providing resources to the homeless.

"Change takes time," Chuck said. "It's a slow process. But I want people to know that we are out here doing our best."

At times, doing their best takes an emotional toll. Chuck pauses briefly in the middle of a story about a single father he helped into housing. He and his team didn't want the man and his eight year old daughter to spend another night on the riverbed. They decided they weren't leaving until he was housed. Choking back emotion, Chuck shares how the eight year old girl returned from school to the room they'd found, and gave him a big hug saying simply, "thank you."



PROJECT COMPLETION STATUS

The new OC Animal Care shelter will consist of a twostory administration building that will house the cattery, exotic animals, veterinary services, customer service and animal control. Visitors will pass through the shelter lobby onto a curved promenade lined with five kennel pavilions, multiple dog play yards, a barnyard and "rabbitat." OC Public Works, on behalf of OC Animal Care, is managing the design and construction of the new Animal Care facility in the City of Tustin. This shelter will replace the current aging shelter in Orange built in the 1940s. Upon the completion of this project, the County of Orange will have a wonderful, new place for residents to adopt their forever pet.

RECENT CONSTRUCTION ACTIVITIES



The main building foundation is complete.

- Main building concrete walls are lifted and braced in place.
- Second floor steel framing is installed with floor decking being lifted and ready to be installed.
- Kennel Pavilion building foundations have been poured.
- Beginning installation of Kennel Pavilion concrete block walls.

- Indoor / outdoor temperature-controlled kennels to provide ample space and comfort for dogs in our care
- Multiple dog exercise yards to facilitate enrichment and dog play groups

John Wayne Airport Personnel and Mutual Aid Partners Conduct Successful Mass-Casualty Incident Exercise

On April 14, 2017, John Wayne Airport (JWA) conducted a full-scale, mass-casualty exercise involving more than 500 volunteers, observers, support staff and emergency responders. Staged on the west side of the airfield, the drill allowed Airport officials and emergency responders to test and practice operational capabilities in response to a simulated aircraft accident involving a 90-passenger, commercial service airplane and a four-seat helicopter.

"While it is our hope that we never experience any of the emergencies we train for, we are committed to providing the very best response to our passengers, tenants and our community," said Airport Director Barry A. Rondinella. "Exercises like this are a key component of emergency response planning and preparedness. We are proud to work in concert with our partner agencies to ensure the Airport is ready in the event of an emergency."

The airplane fuselage and helicopter were positioned on the airfield for purposes of staging "victim" passengers for the drill.

During the drill, Orange County Fire Authority (OCFA) arrived on the scene and extinguished a virtual fire associated

with the crash. Emergency responders then evacuated and triaged volunteer "victims" who were taken to a simulated hospital by ambulance or helicopter, or to an on-site Passenger Reception Area. Volunteers, evaluators and observers in these locations were briefed by the airline, Airport staff, American Red Cross, Orange County Health Care Agency and other mutual aid responders on hospital operations and the support and assistance provided to passengers, crew and family/friends.

The Federal Aviation Administration (FAA) requires that commercial service airports conduct a full-scale, mass-casualty exercise every three years to maintain Title 14, Code of Federal Regulations, Part 139 Airport Certification.

In intervening years, JWA conducts tabletop exercises to review emergency response plans with its mutual-aid partners in a classroom setting. Subsequent to this year's full-scale exercise, JWA will have an Airport recovery exercise in late May 2017 which will focus more specifically on Family Assistance Center operations and the long-term recovery efforts following this type of incident.

In addition to John Wayne Airport, the following agencies participated in the drill:

- Orange County Sheriff's Department, Airport Police Services were first on scene with 30 Deputies and Sheriff's Special Officers, nine Sheriff vehicles and one helicopter, providing law enforcement support.
- Orange County Health Care Agency, Emergency Medical Services provided coordination and support of ambulance response, as well as coordination with the American Red Cross for patient location at hospitals.
- Orange County Fire Authority responded with more than 50 vehicles and 200 personnel from Aircraft Rescue and Fire Fighting Station 33 at JWA, neighboring fire stations and their engines, medic units, command vehicles, a heavy rescue vehicle and various support vehicles, including one helicopter.
- American Red Cross, Orange County Chapter simulated the creation and functionality of a Friends and Family Reception Center and a Family Reunification Center in partnership with Alaska Airlines, and provided care and emotional support to victims and their families following the aircraft incident.
- Alaska Airlines represented the airline involved in the incident and simulated their response to volunteer passengers, families and friends.
- More than 40 ambulances, coordinated by Care Ambulance, responded and transported victims to a simulated hospital, as well as the Orange County Fire Authority, Orange County Sheriff's Department and Mercy Air with airlift operations.
- Representatives from Long Beach Fire, Newport Beach Fire, Costa Mesa Fire, Huntington Beach Fire, City of Orange Fire and Garden Grove Fire took part as evaluators and participants, enabling them to provide informed, unbiased feedback.
- More than 100 members of local Community Emergency Response Teams (CERTs) participated as volunteer victims and in other volunteer roles.

County Connection editorial staff talked with Kim Derrick, Program Manager in Employee Benefits, about the upcoming wellness period. The County's 2017-18 Healthy Steps program will launch on June 1.

() CAN YOU TELL ME ABOUT YOUR ROLE AS PROGRAM MANAGER IN EMPLOYEE BENEFITS?

As part of my job responsibilities, I manage the County's StayWell contract, which encompasses portions of our wellness program. StayWell is the administrator our OC Healthy Steps program and website. I meet with them on a weekly basis, and right now our calls our focused on our "Right This Weigh" challenge we have going on as well as preparing for our upcoming OC Healthy Steps Wellness program period. I also work with our health plan vendors and the Benefits Management team to determine what wellness challenges and activities are needed and what newsletter articles would be most helpful based upon the health and wellness needs of our County employees.

WHAT SHOULD COUNTY EMPLOYEES KNOW ABOUT THE UPCOMING WELLNESS PERIOD?

This year the Wellness program will be from June 1 through August 26. We'll have communications going out in the mail mid-May to announce the participation period dates and describe the activities are that need to be completed.

One thing to note is that we send the mailers out to employees' home addresses. We encourage employees to keep their addresses up to date. In addition, we send out information and reminders through the County's "Global Address List" via email. However, we realize that not everyone has a County email account; so we encourage employees to populate their StayWell account profiles with a good email address, even if that is a personal email address. (To update your account profile, go to the OC Health Steps Healthy Steps website, click on "My Account," enter updates and click "Save.")

WHAT IS NEW ABOUT THE HEALTHY STEPS PROGRAM THIS YEAR?

When the 2017-18 wellness period launches on June 1, 2017 we will also be launching a new OC Healthy Steps website with a brand-new look and feel. The new website will be customizable, allowing you to move parts of webpages around to where you want them based on what is most important to you.

The current site has weight-tracking and step-tracking functions, but you have to enter the information manually. In the near future, participants will have the ability to connect with employees' fitness trackers automatically. The new website will be able to sync with your device and have your activity information populated automatically to the website. With these new features, it is our hope that employees will use the OC Healthy Steps website year-round, beyond the three-month wellness period.

() HOW CAN EMPLOYEES GO ABOUT COMPLETING THEIR WELLNESS PROGRAM ACTIVITIES?

There are three activities that employees need to complete to receive the Wellness Credit for 2018: a biometric screening, a health risk assessment, and a non-smoking attestation. Employees can complete their wellness activities, in any order, during the participation period from June 1, 2017 – August 26, 2017.

Employees can do their non-smoking attestation right away – it takes just a few seconds to attest to one of the nonsmoking or stop smoking statements. Then they can do most of their health risk assessment without including the biometric data. Once they complete their biometric screening, the information will automatically populate into the health risk assessment.

Employees can get their biometric screening done in one of three ways – using their personal health care provider, going to a Quest lab or getting it done at an onsite screening. Information about the on-site screenings, Quest Lab appointments, and the Biometric Health Screening Confirmation form will be available on the OC Healthy Steps Wellness Program website on May 19, 2017.

WHY IS IT IMPORTANT FOR EMPLOYEES TO TAKE ADVANTAGE OF THE HEALTHY STEPS PROGRAM?

We encourage employees to participate so that they can receive their OC Healthy Steps Wellness Credit for 2018 and become aware of their risk factors and key numbers that impact their health (such as your cholesterol, blood sugar, and blood pressure), as well as to identify what they can do to maintain or improve their health. Our employees have done a great job this last year in fact, the average number of health risks decreased by 4.5% from 2.22 to 2.12 with an estimated health cost care savings of \$1.3M. This is a 137% greater risk reduction than StayWell's norm of 1.9%

The program also won a 2016 National Association of Counties (NACo) National Achievement Award for our OC Healthy Steps Wellness Program in part due to the significant employee participation in the core and voluntary components of the program.

• ONCE EMPLOYEES HAVE COMPLETED THE HEALTHY STEPS PROGRAM, WHAT CAN THEY DO NEXT TO IMPROVE THEIR WELLNESS?

What's great about the StayWell website is that it has so many other resources available. For example, it has online selfdirected coaching. Say you want to start eating better; there is a self-directed coaching on nutrition. If you want to reduce your stress, there is a self-directed coaching on stress-management. In addition, we have a wellness coach on-site, Holly Lattimer, who is a great resource. Some people really prefer in-person coaching, and Holly is available to meet with people across County departments and agencies. Inconsistency in Availability and Marketing of Healthy Products in Orange County

Findings from a new Healthy Stores for a Healthy Community survey show that only 13 percent of stores in Orange County advertised healthy products on their storefronts, while 69 percent of stores marketed unhealthy products and the availability of e-cigarettes has grown nearly 21 percent since 2013.

These findings are part of new research on the availability and marketing of tobacco products, alcohol, condoms and healthy and unhealthy food options in California stores that sell tobacco. An OC Register article here talks about how e-cigarettes are easier to find in Southern California stores rather than fresh produce. Health supporters gathered in March to raise awareness about the results and educate retailers on how they play a critical role in our community's health.

"This survey found that our community's youth are exposed to many unhealthy messages and choices," said Amy Buch, Division Manager, Health Promotion Division. "Our Tobacco Use Prevention Program (TUPP) is committed to continuing to work with retailers and local partners to provide accurate information to help make the healthy choice the easy choice for our residents."

The survey is the largest of its kind and builds upon initial research released three years ago in March 2014. It provides insights into changes in the availability and marketing of the studied products from information collected in the summer of 2016 from more than 7,100 stores in all 58 California counties

including pharmacies, supermarkets, delis, convenience and liquor stores as well as tobacco-only stores.

Motel Assistance Program Continues to House More Participants

Since its launch in February, the Motel Assistance for Behavioral Health Homeless program continues to successfully house participants who are struggling with a mental illness or substance use issue and currently work with our Behavioral Health Services (BHS) Outreach and Engagement (O&E) team.

Our O&E team identifies participants who are working toward their behavioral goals and coordinates with contract providers to place them in a motel for up to seven days to support their recuperative care, linkage to behavioral health programs or after they are matched to a housing opportunity through the **Coordinated Entry System**.

O&E staff had been working with a woman who was staying in the riverbed and was referred to the Courtyard. She was pregnant at the time and recently became ill, which resulted in a hospital visit and early delivery.

The participant shares how the program helped her and her baby:

"Because of BHS O&E team members Tammy Waitman and Araceli Vidales and the Motel Assistance Program, I was able to stay in a motel room to recover from my emergency c-section and be close to the hospital to see my daughter. They got me a week's stay, which was perfect timing because on the sixth day, my new apartment was ready and I moved in. This was such a blessing because if it hadn't been for the motel stay, I would have been back on the streets. I thank staff and the Health Care Agency for their kindness and generosity for going above and beyond to help me and my baby."

BHS O&E provides outreach services to individuals of all ages who are homeless, at risk of homelessness, and struggling with a behavioral health condition. The team develops trusting relationships with homeless participants in any public area and works with them to reduce barriers to housing due to behavioral health impairments and facilities linkage to available resources and support services. Airport SSOs Awarded Medals at 2017 OCSD Medal of Valor Ceremony



On a busy Monday afternoon in November at John Wayne Airport, Orange County Sheriff's Department Special Officers **Carlos Castro, Rafael Ojeda** and **Spencer Sheflin** were dispatched to the curbside of Terminal 'C' for a medical aid call.

Rafael and Spencer responded to the scene while Carlos retrieved an automated external defibrillator (AED).

Rafael and Spencer found a man sitting in his car, unconscious and not breathing. The man's wife and son frantically were asking for help. The SSOs gently pulled the man from the car and placed him on the sidewalk.

After a quick assessment, the SSOs determined the man had no pulse and was not breathing. They began CPR just as Carlos arrived with the AED. The SSOs delivered a shock, assessed the man's vitals and continued CPR.

A few moments later, the victim took a sudden, deep inhale and started breathing on his own. The SSOs monitored the man until paramedics arrived and the man was taken to the hospital.

The quick and efficient work of the SSOs saved the life of the 63-year-old heart attack victim. The SSOs were awarded medals for Lifesaving at the 2017 OCSD Medal of Valor ceremony.



One Employee's Journey into the County Family

The mission of the Social Services Agency (SSA) is to deliver quality services that are accessible and responsive to the community, encourage personal responsibility, strengthen individuals, preserve families, and protect vulnerable children and adults. One of SSA's main programs, the California Work Opportunity and Responsibility to Kids (CalWORKs) is vital in adhering to this mission. And, while we are privileged daily to see our families succeed in the CalWORKs Welfare-to-Work (WTW) program and achieve self-sufficiency, their successes are often not shared with our County family. As such, we wanted to share an incredible success story of one of our clients – a success that hits very close to home.

As you may already be aware, the Employment Preparation Program (EPP) is a component of the CalWORKs program and provides expanded subsidized employment opportunities. The goal of this program is to help CalWORKs clients that are participating in WTW gain valuable work experience through subsidized employment in public, non-profit, or private worksites. Several county departments, including SSA, have begun to utilize EPP participants in their various programs. The In-Home Supportive Services (IHSS) program was one of the first SSA programs that welcomed the opportunity to become an EPP worksite after the County Executive Office shared its support for expanding EPP Worksites throughout County agencies.

In October 2016, through EPP, Cathryn Foltz began her journey with the County assisting IHSS clerical staff. Upon entering the program, Cathryn possessed a great deal of enthusiasm and quickly demonstrated her ability to learn and adapt to the fast-paced environment. In December 2016, after only two months in the program, Cathryn transitioned from an EPP participant to a contracted temporary employee through Lloyd Staffing Agency. As a temporary employee, she played a vital role in the IHSS Imaging Project and the completion of imaging over 27,000 IHSS active cases. Cathryn openly communicated her desire to be of service to others and become a permanent SSA employee, with specific aspirations to become a social worker. IHSS supervisors provided Cathryn with skill building opportunities such as resumé building, mock

interviews, and mentorship. She then applied that knowledge in applying for jobs and participating in job interviews. Along the way, she faced a few barriers but she remained positive, receptive, and persistent on her quest to seek permanent employment.

We are thrilled to share that, effective February 17, 2017, Cathryn officially accepted a full-time position with Orange County's Clerk of the Board as a Board Services Specialist. We would like to congratulate Cathryn on persevering in the face of adversity, and we wish her the best in her future endeavors. JOURNEY THROUGH ORANGE COUNTY'S ORIGINS, OBSTACLES, AND OPPORTUNITIES

ORANGE COUNTY & THE GREAT WAR BY CHRIS JEPSEN

his spring marks the centennial of America's entry into World War I. More than 1,550 Orange Countians served in the armed forces during what was naively called "The War to End All Wars."

Orange County was braced for battle by late 1916. New Red Cross chapters in Fullerton, Santa Ana and Anaheim made surgical dressings, sweaters and socks for soldiers; gathered clothes for war orphans; and much more.

The United States entered the years-old conflict on April 4, 1917, after continued U-boat attacks and attempts by Germany to ally with Mexico and Japan against us. Within a week, 4,694 Orange Countians volunteered for military service – most of them ineligible.

On the home front, Orange County rationed meat, wheat, sugar, electricity and other commodities; provided ROTC programs; held parades for its fighting boys and opened a mill in Santa Ana to make Army blankets. Bond drives and other fundraisers for "our boys" were seemingly endless, and Orange County surpassed all Liberty Loan quotas. Liberty gardens were planted and the Orange County Farm Bureau was formed to increase food production. The American Protective League opened an Orange County Division to watch for suspected local German sympathizers. Store display windows were strewn with patriotic bunting, Huntington Beach's Pacific Coast Oilcloth factory was retooled to make American flags, and vast quantities of beans were grown to supply the military's mess halls.

Among the local California National Guard outfits engaged in "The Great War" was Santa Ana's Company L. They were ultimately sent to France, where they were spilt up to fill gaps in the First Army as men were killed or wounded.

One of Orange County's more notable war heroes was Company L's commander, Captain Nelson Holderman of Tustin. He was assigned to the 307th Infantry and was central to the "Lost Battalion's" famous stand at the Argonne Forest. Outnumbered, pinned down by enemy fire for five days, and under "friendly" artillery fire, they took enormous casualties. Holderman was wounded five times, but still "dragged himself under heavy machine gun fire" to two of his wounded men and carried them to safety. The Americans refused to surrender and the Germans redoubled their attack. Holderman was out front, holding down the right flank and firing his pistol point-blank into oncoming waves of enemy infantry. He received another wound but stayed afoot and "inspired the brilliant defense that repulsed the Germans." For his heroism, Holderman was awarded the Congressional Medal of Honor and a Distinguished Service Cross.

Another example was Santa Ana's highly decorated Cpl. Jack Fisher, who acquired terrible injuries and PTSD while earning his heroic war record. He later became the Register's staff artist, a beloved figure in the community, the namesake of Fisher Park, and an important voice for disabled veterans.

By the war's end on June 28, 1919, more than 38 million people had perished in the conflict, including 54 from tiny Orange County. Locals celebrated the armistice by going outside and making as much noise as possible with bells, guns, fireworks, pots and pans. Effigies of Kaiser Wilhelm were burned and a large confetti-strewn parade was held through Downtown Santa Ana.

The County Archives has a small display about Orange County's involvement in WWI on exhibit throughout 2017 on the first floor of the Old Courthouse in Santa Ana.

Privacy on the internet has become a growing concern, especially when more people are using it for professional, personal business, socializing, and entertainment. Personal, sensitive and confidential information that is sent over the internet is not necessarily secure.

Many websites that we access have URLs that start with https. Hyper Text Transfer Protocol Secure (HTTPS) is a protocol over which data is being sent between your browser and the website that you are connecting to. This means your connection is encrypted secure.

You may not realize it but you probably use HTTPS on a daily basis. Popular email services and online banking applications rely on HTTPS to ensure communication between your computer or mobile device (such as a smart phone) and their servers are encrypted. This is accomplished by validating a type of identification that IT professionals refer to as a certificate.

If the certificate is not validated, it means the website has failed to verify its identity to the user (you), the computer user trying to access the site. It is at this point; the user is then presented with an error that is certificate validation error.

Upon receipt of the error, the user may choose to proceed at their own risk, but this is not recommended due the risk of the connection not being with the website the user thinks they are attempting to access.

The HTTPS process still considered to be secure, but it is no longer as safe as it once was due to the increase in sophistication of hackers who are able to exploit communications between systems using various techniques.

RECOMMENDATIONS TO PREVENT FROM BEING A VICTIM OF EXPLOITED COMMUNICATIONS BETWEEN SYSTEMS:

• Don't give out any private information to anyone that you do not know or who does not have any legitimate reason for it.

• Don't provide personal, confidential, or sensitive information online unless you know you are using a secure, trusted web page. Go directly to the website by entering in the web address from your browser (Internet Explorer or Google Chrome). Don't click on or copy and paste any links from unsolicited emails.

• Don't put any sensitive information in a location that is accessible from the internet.

• Whenever possible, use secure wireless networks when working with sensitive information over the internet.

• Ensure secure transactions are conducted over connections use HTTPS. If you login to an HTTPS site and you notice the letter S is stripped from the word HTTP, there is a good chance something is wrong.

Workplace Safety - May Is Better Hearing Month

Did you know that the ear's malleus, incus and stapes (otherwise known as the hammer, anvil and stirrup) are the smallest bones in the human body and all three together can fit on a penny? So what is the risk for hearing loss.....approximately 30 Million Workers exposed to hazardous levels of noise in the work place experience permanent damage.

How? Hair cells found in the inner ear are small sensory cells that convert sounds we hear into electrical signals and send "sound energy" to our brain. Once damaged by levels of noise over 85 decibels (dB) for extended periods of time, the hair cells cannot grow back and permanent hearing loss is a reality. Noiseinduced hearing loss levels to be aware of are:

- 90 dB Hair dryers, blenders, and lawn mowers
- 100 dB MP3 players at full volume
- 110 dB Concerts, car racing, and sporting events
- 120 dB Jet planes at take off
- 130 dB Ambulances and fire engine sirens
- **140dB** Gun shots, fireworks, and custom car stereos at full volume

Warning signs that your workplace may be too noisy and a problem if:

- You hear ringing or humming in your ears when you leave work
- You shout to be heard by a coworker an arm's length away
- You experience temporary hearing loss when leaving work

If untreated, hearing loss can affect the quality of your life. The cost may result in strain relationships with family, friends, and co-workers; impact your earning power on the job; prevent your ability to understand what people are saying, and doing the things you used to enjoy. The good news is that exposure to noise and noise-induced hearing loss is **100 % preventable!**

Safety and Loss Prevention's Hearing Conservation Program provides information, guidance, and training to protect County employees from the harmful effects of noise in the workplace. Agencies/Departments that actively monitor their employees for hazardous levels of exposure are OC Animal Care, OC Parks, OC Probation, OC Public Works, OC Sheriff, and OC Waste & Recycling.
